| Course Name | Certificate course in Clinical Fellowship in Geriatric Oncology A one-year fellowship in Geriatrics aimed to produce internists with specialty training in the field of Geriatric medicine. |
| Focus | The course aims to provide hands-on training to enable the Fellows to provide comprehensive and interdisciplinary health care and rehabilitation of the older adult and carry out research in the field of Geriatric Medicine |
| Course Duration | One year |
| Seat (Per year) | One |
| Course Details | The fellowship course shall be a considered part of senior Residency. Since the total tenure of Senior Residency is 3 years. (Including previous experience as SR the candidates are required to declare the period of training of service undertaken in other institution as Senior Resident at the time of applying. |
| Eligibility criteria | Bonafide Indian Nationals, NRI and foreign candidate are eligible to apply MD /DNB in General Medicine or Geriatric Medicine Must be recognized by the MCI/RMC at the time of joining. Post graduate qualifications from Department /institutions where MCI recognition has not been formally granted (for example: under consideration) will not be considered and candidature rejected at any stage. |
| Documents required | Certificate of Qualifications Experience certificate NOC (in case of currently employment) <u>Other documents</u> Birth Certificate ID Proof (Copy of license/Passport / Pan Card/Adhar Card) Two Recent Passport size Photographs |
| Selection Criteria | Selection will be based on the evaluation of performance followed by interview. |
| Reservation | There is no reservation of seats for any category. |

| Application Form | The eligible candidates may send their duly completed application in the prescribed format at http://bmchrc.org/education and Research in the academic column. Candidate should read the instructions carefully before filling up the application form. |

| Application fees | Application form fee amount is Rs 1000/-(One thousand Only). Candidates have to pay online payment. Once the application fee paid will not be refunded any circumstances. |
| Application Process | Interesting candidates fulfilling eligibility criteria should complete the application form as per instructions online. The hardcopy of application along with copies of all relevant certificates and documents are required to bring at the time of interview/admission. Application will be rejected if candidate provide incorrect /false information in the application form. No correspondence in this regard will be entertained. |
| Age Limit | 35 years as on 31.12.2024 |
| Fees | Selected candidate will be paid as follows at the time of Joining the course. The fee is not refundable if the candidate leaves the course in between. INR - 80,000/-yearly (including GST) (Indian National) INR - 1,00,000/-yearly (including GST) (Foreign National) |
| Accommodation | Accommodation is to be arranged by the candidate. |
| Stipend | 90,000/- per month and other norms as per hospital policy. |
| Terms | During the training period the student shall not apply any post or any other courses. Persons working in the Govt organization /autonomous bodies must send application through their institution head. |
| Interview Scheduled | Every year in the Month of (January & July) |
| Method of Selection | Interview by selection committee Executive Director Head –Medical Oncology One Sr Consultant (Surgical Oncology) No TA/DA will be admissible for attending interview. |
| Medical Examination | Joining of selected candidate is subject to medical fitness. The decision of the Board shall be final. Withholding information about current or past illness/treatment/pregnancy status if discovered at a subsequent stage may result in appropriate disciplinary action. |
| Joining | If a candidate fails to join the course by the date stipulated in the selection letter, the offer shall automatically stand cancelled and the seat will be offered to candidates in the waiting list in the order of merit. |
| Duties and Responsibility | Student admitted to Fellowship Course in Geriatric Oncology shall simultaneously work as Senior Residents. They will be required to perform such work as may be assigned to them and is necessary in the interest of patient care, teaching, training, research and in Emergency services as and when required. Candidates will be entitled for 10 days leave (CL) during the entire period of course. |
